"Defendants in these kinds of cases, particularly in New York City, often start out at a disadvantage," Blau says. "Juries tend to be sympathetic toward the plaintiffs. It's our job to get the jury to focus on the facts and the judges on the legal issues." To that end, founding partner Vincent Errante continues to travel the country trying cases and helping juries stay focused.

The practice is known for its skillful and creative use of legal strategies. Blau has had great success, where others have failed, in getting several high-profile cases severed from consolidated trial groups, and in obtaining early dismissals in other cases at the summary judgment stage. "Consolidation of individual cases for trial is a huge issue in mass tort litigation. It is to the plaintiff's advantage to get as many cases as they can tried together," Blau explains.



"Such consolidations, as they are called, can result in significant prejudice against the defendant, because the individual issues in specific cases can get lost to a jury. So our goal is to find a way to get these cases tried individually, or severed, when we can."

Founding partner Jennifer Darger is nationally known for her effective management and resolution of complex mass tort cases, has long-established relationships with a network of attorneys across the country and continues to rack up an impressive track record for a number of high-profile firm clients.
